

Logistic requirements

It is agreed that ERA is obliged to:



- * appropriately pack, mark and dispatch the goods in accordance with the instructions provided by the Buyer or Carrier.
- * make deliveries in accordance to Incoterms 2020, unless otherwise stated in the agreement, all above shall be agreed in written form - Proforma Invoice.
- * mark the goods in each delivery with logistic labels including Buyer's material number, qty, production batch number (if applicable). Each single or collective packaging must have correct label provided by the Buyer or ERA Standard label.

* immediately provide originals of bill of loading or other shipping documents referring to each delivery of goods, in accordance with Buyer instructions.

* mark each packaging and include description of goods on labels, bills of loading, import invoices, in order to enable the Buyer an easy identification of received goods. In particular, pays attention to:

- Buyer product code number next to product foreign name
- Buyer purchase order number
- Buyer contact details
- HS CODE
- country of origin,
- total net and gross weight.

* Immediately informs Buyer contact person in case of issues regarding timely performance of a confirmed purchase order,

* provides the carrier with the contact information of the Buyer Inspection Manager or Director of Logistic Department

* provides on the delivery document the following information: dimensions of the package (length, width, height), weight and possibility of stacking,


* ensures proper load securing, provide adequate marking on packages with goods prone to damage (i.e. „fragile”), if necessary, ensure labels determining direction the goods arrangement during transport.

Shipping Palletized Items

* Product must be secured to the pallet so it won't shift and all items must be contained on a pallet so no parts fall off during transport. Items should be stacked on a pallet to ensure a flat surface for stacking other products unless the pallet is not able to be stacked on in which case it must be labeled as such. Product must never overhang the pallet and ideally, the pallet size should be at least 80x120 cm or 100x120cm larger than product on all sides. Palletized loads should be no taller than 225cm, (including the height of the pallet). Maximum weight of the pallet is 1500 kgs.

Markings

* If a pallet needs to be handled in a certain way, transported in a certain orientation, contains a heavy end, cannot be stacked, or can only be stacked to a certain height, etc. then the packaging will contain marking or labels to clearly call this out.



No load should be placed on top of the pallet.
